

Limited Registration Contract (AKC Limited Registration) \$ This poodle is sold as a companion. It is NOT to be used for breeding (intentionally or unintentionally). The Buyer agrees to have the poodle spayed/neutered between 18 to 24 months old.	
Full Registration Contract (AKC Full Registration) \$ This poodle is considered to be breeding/show quality. The following conditions will be met before the dog is bred 1. Poodle has completed his/her AKC or UKC Breed Championship OR he/she has achieved at least one performance title. (i.e agility, rally, obedience, agility)
